## **WAIVER AND CODE OF CONDUCT**

By signing this form, I agree that all family members will abide by all rules set forth by the Middlebury Youth Soccer League (MYSL). I hereby give my permission for my child (named on this form) to participate in all the MYSL Activities including but not limited to: practices, games, pictures, and meetings. As a parent/guardian of the child applying to the MYSL, I agree to assume for myself and my child all risks associated with participation in all the MYSL Activities. In the event of any loss, damage, or injury to myself or my child arising out of, in connection with, or relating to any MYSL Activity, I hereby waive, release and absolve from any and all liability or fault for such loss, damage, or injury the following: the MYSL, the MYSL Board, its officers, coaches, supervisors, and participants. I understand that the MYSL will not insure my child against injury from participation in the MYSL Activities and that such insurance is my responsibility.

### **ACKNOWLEDGEMENT OF RISK & ASSUMPTION OF PERSONAL RESPONSIBILITY**

I understand that by participating in the MYSL that my child will be exposed to above normal risks. I also understand that although the MYSL will take precautions to provide a safe environment, it is impossible for the MYSL to guarantee absolute safety. I assume sole responsibility for safety in league play. I accept responsibility to verify with my physician that there are no physical or psychological problems that would prohibit the participation of my child in the MYSL. Additionally, I agree to accept sole responsibility for any injury that my child may sustain while participating in the MYSL. I hereby waive, release, and forever discharge all MYSL organizers, volunteers, board members, and Middlebury Schools from any and all injury or damages arising from participation in the MYSL. Any changes to this form may constitute exclusion from participation in the MYSL.

### **CODE OF CONDUCT**

I will remember that my child plays soccer for his/her enjoyment, not mine.

I will **NOT** give instruction to players, that is the coach's job.

I will teach my child that doing one's best is as important as winning, so that my child will never feel defeated by the outcome of the game.

I will make my child feel like a winner by offering praise for competing fairly and doing their best.

I will encourage my child to play by the rules and resolve conflicts without hostility or violence.

I will **NEVER** ridicule or yell at my child for making a mistake.

I will remember that children learn by example.

I will **NEVER** question the referee's judgment.

I will respect and show appreciation for the volunteer coaches, who give their time to benefit my child.

I realize that the team can be penalized for my behavior and that of my family. I must obey any order by a referee, coach, or league official to leave the vicinity of the field.
